2. Announcements and correspondences

Correspondences:

- ✓ A letter from the Managing Director of Grassalco was received in which he appointed two staff members to participate in the MSG on behalf of Grassalco. Mrs Breidel and Mr Asodanoe whom have participated in some of the meetings last year.
- ✓ A suspension letter was received from EITI International. Suriname is suspended for not reaching the deadline of December to produce the 2021 report. The letter will be shared with the MSG.
- ✓ Invoice received for contribution for year 2024.

Announcements:

- ✓ Varsha was introduced to the MSG. She is the technical officer at the secretariat and motivated to work together in achieving EITI Suriname goals.
- ✓ No date from EITI International yet on 6.2 implementing countries must include disclosures from SOEs on their quasi-fiscal expenditures. This is because of the preparation for the board meeting during the PDAC Conference in Canada. The members are occupied till the 8th of March. Also Esteban was promoted to Regional Director and our country lead now is Jessica Buendia. A meeting will be set up after March 8 with Jessica.
- ✓ On February 19th the National Coordinator participated in the 1st National Coordinators meeting in 2024. Key points were :
 - Outstanding contribution to EITI International (the proposal was made up for years 2022/2023 and will be discussed in the council of ministers. When the Ministry of Natural Resources has approval and authorization we will be needing the MSG members from Finance to help us see this payment through.

- The ToR for hiring an Independent Administrator was discussed in the Board Meeting in Toronto. A template on what needs to be in ToR will be developed and shared with the implementing countries. There soon will be a next coordinators meeting in which the outcomes of the board meeting will be shared.
- A question for the MSG is which are the most significant priorities for the EITI where can EITI create most impact and how?
- ✓ EITI Suriname participated in the workshop mining impacts calculator. The mining impact tool is an economic tool to measure the economic impact of the social and environmental damage caused by gold mining. The objective was to introduce this tool to key stakeholders in Suriname, raise awareness and encourage its adaptation to the Surinamese context, also to gather information and comments for its possible application and strengthen cooperative efforts to address the primary challenges associated with artisanal and small scale mining operations. The participants did some exercises in groups on how the goldmining depends on and/or impacts for example the water quality or water quantity, timber production and none timber forest products and practiced a bit in the mining calculator. Suriname does not have the tool yet but it is in the planning. The National Secretariat was present and also the MSG members Georgetine, Rayah and Rene. The National Coordinator thanked Monique for sharing this invitation because this tool can also be used to promote transparency.
- ✓ In May there will be a regional Conference in Guyana. Hopefully, a lot of members get the chance to participate, since it will be held in our neighboring country. The specific details will be discussed as soon as more information is shared with the secretariat.
- ✓ In the last meeting the MSG members proposed a workshop to be held at the end of March. In agenda point 6 this will be discussed.
