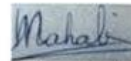

General notes to the financial statements

1. General information

Rosebel Community Fund (hereinafter "R.C.F.") is founded by Rosebel Gold Mines N.V. (hereinafter "Rosebel"). The foundation is incorporated on December 2, 2019, and domiciled in Paramaribo. The address of its registered office is President da Costalaan number 2. The Rosebel Community Fund Foundation was established with the goal of helping to create a sustainable future for the communities surrounding the Rosebel operation, and the Surinamese community at large.

The annual report was authorized for issue by the Board.

2. Significant accounting policies

The principal accounting policies applied in the preparation of this annual report are set out below.

2.1 Basis of preparation

The annual report has been prepared in accordance with generally accepted accounting policies.

2.2 Functional currency

(a) Functional and presentation currency

Items included in the annual report are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The annual report is presented in United States Dollars (USD), which is the foundations functional and presentation currency.

(b) Transactions and balances

Foreign currency transactions are converted into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the conversion at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognized in the profit and loss.

The year-end closing exchange rate for the financial year was as follows:

2.3 Cash and cash equivalent

Cash and cash equivalents include cash at banks, cash in transit and cash on hand. Cash and cash equivalents are valued at nominal value. Unless otherwise stated, the cash and cash equivalents are not restricted for use.

2.4 Capital and reserves

For each project a fixed budget is approved by the board.
The difference between the budget and the expenditures is allocated to reserves with donor restrictions.

2.5 Current liabilities

Liabilities are stated at face value unless otherwise stated.

2.6 Related party transactions

Rosebel is a related party of RCF. Transactions between RCF and Rosebel are executed at arm's length.

2.7 Income

The income consists of funds received from Rosebel Gold Mines N.V.
Rosebel shall provide funding in accordance with article 3 of the bylaws of Rosebel Community Fund. Article 3.1 requires the following:

- a. For the year 2020, a contribution of two and a half million US dollars (USD2,500,000).
- b. Starting 2021, annually a quarter percent (0.25%) of Rosebel's gross annual turnover is allocated to the foundation.

2.8 Expenses

Expenses are based on historical cost and are allocated to the reporting period in which they are incurred.

(a) Project related expenses are expenses for projects made available through specific guidelines mentioned in the foundation's internal regulations and procedures.

Donation application guidelines

- Project proposals are made via the website www.msebelgoldmines.sr.Organizations within the Brokopondo Rosebel Communities of Interest and the Sipaliwini Rosebel Matawai Community of Interest can submit the project proposal at www.rosebelgoldmines.srand/oran be assisted by the Rosebel Community Relations department.
- Eligible recipients of a donation are, but are not limited to the following:
 - ✓ Non-Governmental Organizations (NGOs).
 - ✓ Non-profit organizations
 - ✓ Local community authorities / Local communities

- ✓ Committees for community development
 - ✓ Research institutes
 - ✓ in exceptional cases individuals

- Religious or politically affiliated organizations, organizations that discriminate based on race, gender, ethnicity, or credo are not eligible.

The projects are categorized into budget categories, depending on the amount of the proposal.

- Category A: Max USD2,500
- Category B: Min. USD 2,500 and Max. USD 20,000
- Category C: Min. USD20,000

(b) Operational expenses

The operational expenses are not directly attributable to the revenues. These consist of compensation fee, marketing, and administrative expenses.

2.9 income Tax

The foundation will get in contact with the Ministry of Finance (Tax department) to be exempted from tax obligations.

Basis of the cash statement

Projects approved and carried out in 2024

1. Schools Complex Brokopondo

The district of Brokopondo, one of the districts in Suriname does not yet have a secondary school, which means that children have to travel daily to the district of Wanica or Paramaribo to attend secondary education the aforementioned children are forced to choose residence in the aforementioned districts, far from their parents and loved ones.

The Traditional Authority made a request to the Rosebel Gold Mines N.V., hereinafter referred to as "RGM", which granted that request in the amount of USD 350,000.

2. Pikin Samaaka bridge

To construct a crossing bridge for the villagers of Nieuw Jacobkondre, Balling, Billawatra and Masalibi. The bridge will be constructed, crossing the Kleine Saramacca River where the villagers are located. The project will commence on March 31, 2024.

The contract sum is USD 255,000 and will be paid in 3 phases.

3. Village Road rehabilitation 0.44 km

The contractor Bouwvast Jankie N.V. will perform the rehabilitation of the following roads:

- The road to Ston Island, from the main road from Bronze road, to the new school there, with a distance of about 0.17 km.
- The road to the community Catholic Church, with a distance of about 0.10 km.
- The Cerenius road, with a distance of 0.17 km.

The contract sum agreed by RCF and the Contractor is USD 64,048, and will commence in August, 2024 and the will be completed in 50 workdays.

4. RCF provide funding to Foundation for Research and Development in Caribbean Communities

RCF was approached to assist in the implementation of the EMSAGS project with the goal of raising awareness among young people in the district Brokopondo, through video productions and script writing, about the dangerous of mercury an cyanide use in small scale gold mining.

A total of USD 11,375 will be made available by RCF to FRDCC.

ONS OORDEEL

Wij hebben de jaarrekening 2023 van de Stichting Staatsolie Foundation for Community Development te Paramaribo, zoals opgenomen op de pagina's 5 tot en met 12, gecontroleerd.

BESCHRIJVING VAN VERANTWOORDELIJKHEDEN MET BETREKKING TOT DE JAARREKENING

Verantwoordelijkheden van het bestuur voor de jaarrekening

Het bestuur van de Stichting is verantwoordelijk voor het opmaken en getrouw weergeven van de jaarrekening in overeenstemming met algemeen aanvaarde grondslagen voor financiële verslaggeving. Onze controle is uitgevoerd met een hoge mate maar geen absolute mate van zekerheid waardoor het mogelijk is dat wij tijdens onze controle niet alle materiële fouten en fraude ontdekken.

Afwijkingen kunnen ontstaan als gevolg van fraude of fouten en zijn materieel indien redelijkerwijs kan worden verwacht dat deze, afzonderlijk of gezamenlijk, van invloed kunnen zijn op de economische beslissingen die gebruikers op basis van deze jaarrekening nemen. ONS OORDEEL

Wij hebben de jaarrekening 2024 van de Stichting Staatsolie Foundation for Community Development te Paramaribo, zoals opgenomen op de pagina's 5 tot en met 12, gecontroleerd.

Naar ons oordeel geeft de jaarrekening een getrouw beeld van de grootte en de samenstelling van het vermogen van Stichting Staatsolie Foundation for Community Development per 31 december 2024 en van het resultaat over 2024 in overeenstemming met algemeen aanvaarde grondslagen voor financiële verslaggeving.

De jaarrekening bestaat uit:

1. De balans per 31 december 2024;
2. De staat van baten en lasten en het kasstroomoverzicht over 2024; en
3. De toelichting met een overzicht van de gehanteerde grondslagen voor financiële verslaggeving en andere toelichtingen.

De basis voor ons oordeel

BESCHRIJVING VAN VERANTWOORDELIJKHEDEN MET BETREKKING TOT DE JAARREKENING

Verantwoordelijkheden van het bestuur voor de jaarrekening

Het bestuur van de Stichting is verantwoordelijk voor het opmaken en getrouw weergeven van de jaarrekening in overeenstemming met algemeen aanvaarde grondslagen voor financiële verslaggeving. In dit kader is het Bestuur verantwoordelijk voor een zodanige interne beheersing die het bestuur noodzakelijk acht om het opmaken van de jaarrekening mogelijk te maken zonder afwijkingen van materieel belang als gevolg van fouten of fraude.

Onze verantwoordelijkheden voor de controle van de jaarrekening

Onze verantwoordelijkheid is het zodanig plannen en uitvoeren van een controle-opdracht dat wij daarmee voldoende en geschikte controle-informatie verkrijgen voor het door ons af te geven oordeel.

Onze controle is uitgevoerd met een hoge mate maar geen absolute mate van zekerheid waardoor het mogelijk is dat wij tijdens onze controle niet alle materiële fouten en fraude ontdekken.

Afwijkingen kunnen ontstaan als gevolg van fraude of fouten en zijn materieel indien redelijkerwijs kan worden verwacht dat deze, afzonderlijk of gezamenlijk, van invloed kunnen zijn op de economische beslissingen die gebruikers op basis van deze jaarrekening nemen. De materialiteit beïnvloedt de aard, timing en omvang van onze controlewerkzaamheden en de evaluatie van het effect van onderkende afwijkingen op ons oordeel.

Wij hebben deze accountantscontrole professioneel kritisch uitgevoerd en hebben waar relevant professionele oordeelsvorming toegepast in overeenstemming met de door onze beroepsorganisatie uitgevaardigde controlestandaarden, ethische voorschriften en de onafhankelijkheidseisen. Onze controle bestond onder andere uit:

- Het identificeren en inschatten van de risico's dat de jaarrekening afwijkingen van materieel belang bevat als gevolg van fouten en fraude, het in reactie op deze risico's bepalen en uitvoeren van controlewerkzaamheden en het verkrijgen van controle-informatie die voldoende en geschikt is als basis voor ons oordeel. Bij fraude kan sprake zijn van samenspanning, valsheid in geschrifte, het opzettelijk nalaten transacties vast te leggen, het opzettelijk verkeerd voorstellen van zaken of het doorbreken van de interne beheersing;
- Het verkrijgen van inzicht in de interne beheersing die relevant is voor de controle met als doel controlewerkzaamheden te selecteren die passend zijn in de omstandigheden. Deze werkzaamheden hebben niet als doel om een oordeel uit te spreken over de effectiviteit van de interne beheersing van de Stichting;
- Het evalueren van de geschiktheid van de gebruikte grondslagen voor financiële verslaggeving en het evalueren van de redelijkheid van schattingen door het bestuur en de toelichtingen die daarover in de jaarrekening staan;
- Het vaststellen dat de door het bestuur gehanteerde continuïteitsveronderstelling aanvaardbaar is. Tevens het op basis van de verkregen controle-informatie vaststellen of er gebeurtenissen en omstandigheden zijn waardoor gerede twijfel zou kunnen bestaan of de Stichting haar activiteiten in continuïteit kan voortzetten. Als wij concluderen dat er een onzekerheid van materieel belang bestaat, zijn wij verplicht om aandacht in onze controleverklaring te vestigen op de relevante gerelateerde toelichtingen in de jaarrekening. Als de toelichtingen inadequaat zijn, moeten wij onze verklaring aanpassen. Onze conclusies zijn gebaseerd op de controle-informatie die verkregen is tot de datum van onze controleverklaring. Toekomstige gebeurtenissen of omstandigheden kunnen er echter toe leiden dat de Stichting haar continuïteit niet langer kan handhaven;
- Het evalueren van de presentatie, structuur en inhoud van de jaarrekening en de daarin opgenomen toelichtingen; en
- Het evalueren of de jaarrekening een getrouw beeld geeft van de onderliggende transacties en gebeurtenissen.
